Upon my arrival I made contact with victim, Laird, in reference to an unknown suspect damaging two of her car tires.

Laird advised that she last saw the vehicle at 2100hrs on 1/1/07 and it was undamaged. When she went out to the vehicle at 0755hrs on 1/2/07 she observed that the front driver side and rear driver side tires were flat. She advised that she had the vehicle taken to Joyce Wrecker and the tires were changed. She advised that Joyce told her that they attempted to inflate her tires that were damaged, and discovered a puncture mark to each tire.

On 1/25/07 I, Officer Roberson #140, responded to 611 Interlachen Parkway in reference to a suspicious incident. I was met, in person, by Reportee, Sheryl Laird. Ms. Laird stated on 1/25/07 she went out to her shed and opened up her clothes dryer and as she opened it up dirt and leaves fell out. Ms. Laird stated she found dirt and leaves inside the clothes dryer and in the filter.

I investigated the clothes dryer and found dirt and leaves inside the the dryer and in the filter. I observed the clothes dryer to be in a garage that was unsecured with the door open.

Ms. Laird stated she thinks her ex- husband, Robert Laird, may be responsible but she also stated she cannot prove it at this time. Ms. Laird stated Mr. Laird has made statements to other family members regarding how she is doing and if she has had any problems at her residence. Ms. Laird stated Mr. Laird told a mutual friend he is going to dump a load of trash on Ms. Laird's front lawn on 3/28/07, her birthday.

Ms. Laird stated she has an injunction for protection, domestic violence against Mr. Laird and he has not yet violated it.

Ms. Laird stated she knew not much could be done at this time but wanted this incident documented in case of any future incidents.
